A RESOLUTION AUTHORIZING TREE REMOVAL

BE IT RESOLVED, that permission be and hereby is granted to Feodora Rucconich, having an address at 90 Utterby Road, Malverne, NY, for removal of two (2) trees located at premises 17 Marwood Road North within the Village; and

BE IT FURTHER RESOLVED, that the permit fees to be charged to the property owner, as set forth in section 143-6 of the Code, be and hereby are waived; and

BE IT FURTHER RESOLVED, that the provisions of this Resolution shall take effect immediately.
